#### Representative Experience

- Representation of Chapter 11 trustee of two related entities that provided services in environmental emergency response, hazardous
  waste management, industrial cleaning, waste minimization, transportation services, and air pollution control technology, and
  emission control services for the maritime industry. Saddled with millions in secured and unsecured debt, the entities were forced into
  an involuntary bankruptcy case by multiple creditors. Through Asa's efforts, the trustee negotiated, obtained Court approval of, and
  consummated a sale of substantially all assets of the debtors.
- Representation of parent company and its multiple subsidiary entities established to develop, operate, and franchise facilities offering
  full-body tracking, free roaming, virtual reality experience for private groups, in connection with their Chapter 11 bankruptcy cases.
  Prior to entering Chapter 11, Asa assisted the company in negotiating a plan support agreement with its secured lenders and equity
  owner (which did not file bankruptcy), and an accompanying restructuring term sheet with its secured lenders, providing a clear
  structure, direction, and deadlines for the reorganization process at the core of the company's game plan for implementing an
  efficient, expeditious, and effective Chapter 11 reorganization. After filing bankruptcy, Asa led the debtor-entities to confirmation of a
  contested Chapter 11 reorganization plan that allowed it to emerge as an ongoing business enterprise.
- Representation of company that created of the Spinning®, Peak Pilates®, CrossCore®, Ugi®, Resist-A-Ball® and Spin Fitness® brands prior to and during its Chapter 11 bankruptcy case. As one of the largest equipment-based education companies, it manufactured home Spinner® bikes, Pilates and functional training equipment, DVDs, and a complete line of Spinning-branded apparel and accessories. Asa was one of the lead attorneys who successfully represented the company in a two-day plan confirmation trial, after which the Court confirmed the Chapter 11 plan. Under the plan, the company restructured its debt, reorganized its efforts, and exited Chapter 11 as a going concern.
- Representation of a retailer of shoes, apparel and accessories, that, at the time it filed Chapter 11, operated 125 retail stores across
  10 states, with Nike product accounting for more than 50% of its sales. As a assisted the company in extensive negotiations with its
  lenders, landlords, the creditors' committee, and other constituencies to close unprofitable stores and shed substantial debt, yet still
  maintain its business model. Through Asa's efforts, the Court confirmed the company's plan of reorganization. The company
  successfully emerged from Chapter 11, having beneficially modified dozens of leases, eliminated millions of dollars of debt, obtained
  new financing, and closed unprofitable locations.
- Representation of Chapter 7 trustee of entity that, prior to the filing and conversion of its Chapter 11 case, was the owner and
  licensed operator of a 204-bed skilled nursing facility. On the trustee's behalf, Asa pursued and prosecuted multiple avoidance
  litigation claims seeking damages in the aggregate of over \$30 million, resulting in settlement agreements favorable to the bankruptcy
  estate and its creditors.
- Representation of the Official Committee of Unsecured Creditors in the Chapter 11 cases of one of the largest publicly traded real estate enterprises in Los Angeles. As a assisted in the negotiation and confirmation of a competing Chapter 11 plan (which the debtor-entitles opposed) that paid general unsecured creditors the Committee's constituency in full, with interest, shortly after confirmation of the plan.
