Mr. Minter has been a frequent lecturer for the Practicing Law Institute and numerous other organizations, as well as being a frequent contributor and columnist for several music trade publications, and is author of a music industry guidebook, Understanding and Negotiation 360 Ancillary Rights Deals.

As a recognized leader, Mr. Minter is listed in *Marquis Who's Who in America*, *Marquis Who's Who in American Law, Marquis Who's Who in Entertainment*, *Marquis Who's Who in The East*, and *Marquis Who's Who amongst Black Americans*. He has also been inducted into the Knights of Malta, O.S.J.
